Rules & Regulations

1. Battle of the Bands will be held at 6:00p.m. June 16, 2016 at the Beavers Bend Amphitheater
2. The Grand Prize will be \$1,000 and be the opening act for the Saturday Night Headliner on June 18, 2016
3. 5 Bands will be chosen to perform at the Battle of the Bands - If chosen to perform you will be notified no later then May 15, 2016 - If not chosen entry fee will be refunded.
4. Bands must submit completed entry form & pay entry fee before deadline.
5. All bands must contain a minimum of three (3) members.
6. Foul language, inappropriate/controversial topics, distasteful behavior will be immediate disqualification. All songs must be appropriate for a family environment.
7. The use of any illegal substances will not be tolerated. If any band member is suspected to be under the influence of an illegal substance, the entire band will be disqualified immediately and the proper authorities will be notified.
8. Bands will play for 20-30 minutes. Original or cover songs may be performed.
9. All bands agree to have their name, voice, and/or likeness used in any advertising or broadcasting material relating to this contest without compensation or rights to royalties for such use.
10. Any band member under the age of 18 must have a parent or guardian sign the registration form that they have read and understand the rules and regulations.
11. All participants are required to be courteous and respectful toward other participating musicians.
12. Bands may not use pre-recorded sound material. All bands must play live.
13. Band must checkin at Amphitheater no later then 5:30 p.m. on Thursday June 18, 2015 and winner must checkin no later then 5:00 p.m. Saturday June 20, 2015
14. Judging is done on a 1 -10 scale by 3 judges. The 3 criteria on which the bands will be judged are explained below. The final criteria, however, will be crowd reaction. How loud can you make our show area. BRING YOUR FANS!!!
 - A. Music (This criteria is based on clarity, lyrical content and overall musical performance) 1-10
 - B. Stage Presence and Crowd Interaction (This criteria is based on how well the band "rocks out" and how well the band connects with the crowd) 1-10
 - C. Originality 1-10
 - D. Crowd Applause 1-10
